COLLECTION OF DATA

Data collected in a Non-Automatic Way

<u>Personal Data You Specifically Provide to the Site:</u> While using the Site, we may ask you to provide us with certain personally identifiable information, specifically authorized at law, for purposes such as facilitating communications with you. Personally identifiable information may include, but is not limited to:

Data collected in an Automatic Way

Non-Identifiable Data: Like many other websites, this Site may automatically collect limited amounts of certain standard non-identifiable information regarding Site users, traffic monitoring and statistical purposes, such as the Internet Protocol (IP) addresses of the computers being used to access the Site, operating systems and the types and versions of browsers used to access the Site, Internet Service Providers used by visitors to the Site, the date and time visitors access the Site, the sections of the Site users visit. <u>Other disclosures:</u> We will not sell or disclose user personal data that you provide on the Site to any third parties except:

- In accordance with the terms of this Privacy Policy; or
- To comply with legal requirements such as a law, regulation, warrant, subpoena, court order or any legal proceedings; or
- In emergency situations in which we believe that the life, health or safety of a member or other person may be in danger
- Protect the personal safety of users or the public
- It is to prove or protect our legal rights in which case we may be required to disclose such information to bodies such as, but not limited to, Canadian regulatory authorities.

<u>RETENTION OF PERSONAL DATA</u>

Rehabilitation Management Inc. will retain user's Personal Data only for as long as is necessary for the fulfillment of the purposes for which it was collected or as required by law. We will retain and use Personal Data to the extent necessary to comply with our legal obligations (such as if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.
